**DECLARATION OF LANGROCK SPERRY & WOOL, LLP
IN SUPPORT OF PLAINTIFFS' MOTION FOR AWARD
OF ATTORNEYS' FEES AND REIMBURSEMENT OF EXPENSES**

I, Emily J. Joselson, Esq., declare as follows:

1. I am a partner at the law firm of Langrock Sperry & Wool, LLP. I submit this Declaration in support of Plaintiffs' Motion for Award of Attorneys' Fees and Reimbursement of Expenses in the above-captioned litigation. This Declaration sets forth the fees and unreimbursed expenses my firm has incurred in connection with work performed since our firm started participating in this litigation, in February of 2012.

2. My firm has acted as local counsel for the Non-DFA and Non-DMS Farmer Subclass ("Non-DFA/DMS Subclass") in this litigation. During the course of this litigation, my firm has been involved in the following activities, among others: act as liaison counsel between the Court and Plaintiffs' counsel, court appearances, assistance in drafting briefs and pre-trial motions, assistance in settlement negotiations, legal research, and case strategy and analysis.

3. The schedule attached hereto as Exhibit 1 is a detailed summary indicating the time spent by my firm's attorneys and professional support staff who were involved in this litigation, and the lodestar calculation based on my firm's historic billing rates from February 16, 2012, through March 16, 2016. The schedule was prepared from contemporaneous, daily time records regularly prepared and maintained by my firm.

4. The hourly rates for the attorneys and professional support staff included in Exhibit 1 are the same as the usual and customary hourly rates charged for their services in similar complex class action litigation.

5. The total number of hours expended on this litigation by my firm from February 16, 2012, through March 16, 2016 is 153.10 hours. The total lodestar for my firm is \$35,776 at my firm's historic billing rates.

6. As detailed in Exhibit 2, my firm has incurred a total of \$786.39 in unreimbursed expenses in connection with the prosecution of this litigation.

7. The expenses incurred in this action are reflected on my firm's books and records. These books and records are prepared from expense vouchers, check records, and other source materials and represent an accurate recordation of the expenses incurred.
